## OUR CONTRIBUTION TO WBL

- WOODUAL project aims at building up strong and continuative partnership among different stakeholders active in the manufacturing and furniture sector and experts in education and training issues, by piloting workbased learning as a way to <u>update</u> and improve the <u>current professional profiles</u> in wood and furniture sector with the new skills requested from the labour market.
- The project will elaborate guidelines and new methodologies in order to open the road for a more extensive use of dual learning system

# Identified needs and project's contributionNeedsProject contribution

• Youth unemployment rate at 22.5% in April 2014 at the EU level (5.4 million persons aged 15-24, EUROSTAT) with strong differences among MS

• Mismatch between unemployed youth and many job vacancies, especially in the wood and furniture sector (EU Commision, 2014; OECD, 2013)

• Lack of interest from young people towards skilled manual occupations and traditional economic sector

• Most of the CV of **VET programmes** don't cope with new skills

• Dual learning systems are not equally developed across Europe and not easily transferable from "model countries" to all the others

• Contribute to adapt CV and qualification profiles of the Wood Treaters, Cabinet Makers and related Trade Workers

•Contribute to **overcome youth stereotypes** concerning skilled manual occupations

 Increase organizational, social, emotional, entrepreneurial and technological skills and competences in VET students and workers

• **Propose** and test **a cooporation framework** between different stakeholders to define integrated **transnational dual learning models** 

• Support the new Skills Agenda with a sectoral approach to transnational skills needs identification and development through WBL





## AREAS TO EXPLORE

- Explore innovative and integrative approaches to learning outcomes identification and development through WBL;
- Explore barriers and possible solutions to trans-national WBL to address unbalances in the EU «single» labour market;
- Explore the use of ICT to re-think the concept of intra-EU mobility of young workers, combining physical and virtual mobility elements;
- Explore and address legal barriers to full intra-EU mobility of young workers
